1. Provision of the PGG Wrightson Mercury Energy Plan benefits is only available to current PGG Wrightson Monthly Trade Account holders, and is subject to approval by PGG Wrightson Limited.
2. PGG Wrightson can withdraw approval for billing if you exceed your PGG Wrightson credit limit and/or don't pay PGG Wrightson by the 20th of the month following, and/or if you don't adhere to PGG Wrightson's Customer Terms of Trade (see www.pggwrightson.co.nz > Our Company > Customer Account Terms).
3. If PGG Wrightson withdraws their approval, or if you close your account with PGG Wrightson, you will move to Mercury's standard Prompt Payment Discount plan.
4. PGG Wrightson will bill your PGG Wrightson account the monthly amounts owing on your Mercury account for your electricity consumption and the associated charges, after receiving this information from Mercury.
5. PGG Wrightson will pay Mercury for any amounts due on your Mercury account, even if an amount is disputed by you. You must pay PGG Wrightson the full amount of all charges from Mercury even if you dispute them. You must take up any disputes directly with Mercury as outlined in their Standard Terms and Conditions for Business Holders.
6. This Plan may not be combined with any of Mercury's other partnership Plans.
7. This Plan is available for your non-Half Hour Register metered ICPs and/or your Half Hour Register ("HHR") metered ICPs but the discount (of 12%, as at the time of printing) does not apply to the HHR metered ICPs.
8. Mercury reserves the right to change the terms of the Plan, by giving you 30 days written notice, if their contract with PGG Wrightson ends.
9. This agreement is also subject to Mercury Energy's Standard Terms and Conditions for Business Customers, which is available at www.mercury.co.nz/terms, except that your obligation to pay the charges under those terms and conditions is to PGG Wrightson not to Mercury. When the Mercury energy charges are debited to your PGG Wrightson Monthly Trade Account then PGG Wrightson's Terms of Trade also apply to the extent PGG Wrightson deems relevant.
