### RURAL SUPPLIES



Stores are open, including Saturday trading.

All visitors must or scan or sign in, wear a face covering and sanitise hands on entry when visiting a PGW site.

2 metre physical distancing required between people.

Payment instore by PGW account, credit card, EFTPOS or cash.

Technical Field Reps and Technical Team able to travel between regions for on-farm visits.

On-farm services can be conducted face to face maintaining 1 metre physical distancing.

### FRUITFED SUPPLIES



Stores are open, including Saturday trading.

All visitors must or scan or sign in, wear a face covering and sanitise hands on entry when visiting a PGW site.

2 metre physical distancing required between people.

Payment instore by PGW account, credit card, EFTPOS or cash.

Online purchases available at [store.pggwrightson.co.nz](http://store.pggwrightson.co.nz).

Technical Horticultural Reps and Technical Team able to travel between regions for on-farm visits.

On-farm services can be conducted face to face maintaining 1 metre physical distancing.

### WATER



Water branches are open.

All visitors must or scan or sign in, wear a face covering and sanitise hands on entry when visiting a PGW site.

2 metre physical distancing required between people.

Payment by PGW account, credit card, EFTPOS or cash.

Water Reps and Service Technicians able to travel between regions for on-farm visits.

Maintenance, servicing and installation can be conducted maintaining 1 metre physical distancing.

### LIVESTOCK



Regional offices are open.

All visitors must or scan or sign in, wear a face covering and sanitise hands on entry when visiting a PGW site.

2 metre physical distancing required between people.

Livestock saleyards open with some restrictions on numbers attending and some livestreamed on bidr®

Livestock paddock sales conducted by agents.

Livestock sales available via bidr® - bidr.co.nz

Livestock Reps and Genetics Specialists available to travel between regions for on-farm visits.

On-farm services can be conducted face to face, maintaining 1 metre physical distancing.

Velvet processing fully operational.

### WOOL



Wool stores and offices are open.

All visitors must or scan or sign in, wear a face covering and sanitise hands on entry when visiting a PGW site.

2 metre physical distancing required between people.

Wool auctions able to proceed.

Wool Reps able to travel for farm visits, maintaining 1 metre physical distancing.

### REAL ESTATE



Real Estate offices are open.

All visitors must or scan or sign in, wear a face covering and sanitise hands on entry when visiting a PGW site.

2 metre physical distancing required between people.

Agents able to appraise, list and market properties.

Buyer property viewings and open homes are permitted, maintaining 2 metre physical distancing.

Pre-settlement inspections can be conducted.
