PGG Wrightson Ltd (PGW) LandMarks Photo Collection and 2020 Calendar Competition Terms

PHOTO REQUIREMENTS

1. You can submit photos at any time. All photos must be submitted online via the PGW LandMarks Photo Collection website which can be found at www.pggwrightson.co.nz. There is no limit of photos per person per month.
2. Photos must be submitted into one of the category options available and must meet PGW LandMarks Photo Collection [Submission Criteria](#).
3. Photos will be visible in a photo gallery on the PGW LandMarks Photo Collection website during the month they are submitted. Photos will be eligible for public voting at the end of that month's submission period.
4. The top 3 photos that receive the most public votes during the month they are submitted will be automatically shortlisted to the PGW 2020 Calendar Competition People's Choice Award, if all other criteria are met.

STORAGE

5. PGW may store electronically any photos submitted and to use all photos free of charge in any of its online and print publications for a period of ten years, noting that once printed, images are permanent.
6. PGW and the photographer will jointly own the copyright of any submitted photos.

CONSENT

7. [Any persons photographed](#) must have given consent to be photographed and the appropriate written consent documentation completed in full and provided to PGW on request. Any persons photographed who are [under the age of 18](#) must have the appropriate written consent documentation completed in full by their parent/guardian and provided to PGW on request.
8. [Any property photographed](#) must have the consent of the property owner and the appropriate written consent documentation completed in full and provided to PGW on request. Property that is unrecognisable in the photo (e.g. an extreme close-up or an aerial view of many properties) does not require consent. Photographs taken of public property do not require consent but an address may be requested. PGW reserves the right to establish whether consent is required.
9. Failure to provide documentation of consent for photographed persons or property will deem the photo ineligible for submission to PGW for use, including for the Calendar Competition.

10. All photos may be used by PGW in other promotional material. The photographer gives their permission for all photos to be used.

OTHER

11. Submission of a photo is deemed acceptance of these terms.
12. Photos must be submitted by amateur photographers only. An amateur photographer is defined as someone who engages in photography as a pastime/hobby rather than a profession and does not earn more than 10% of their income from photography.
13. PGW reserves the right to block or remove photos from the LandMarks Photo Collection at its own discretion.
14. The LandMarks Photo Collection is open to New Zealand residents and citizens only. All people submitting photos must be over 18 years of age.
15. PGW is not responsible for photos that go astray.
16. If you fail to adequately fill out the submission form and/or submit a photo, it will not be accepted into the LandMarks Photo Collection.
17. PGW reserves the right to cancel or amend any aspect of these terms and/or the 2020 PGW Calendar Competition at any time, including prizes.
18. Except for any liability that cannot be excluded by law, PGW and its suppliers exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the submission of photos, the Calendar Competition and any prizes.
19. PGW collects and holds participants' personal information solely for the purpose of receiving and using photos and conducting the Calendar Competition and will only use or disclose personal information in connection with this.
20. Employees and contractors, and their immediate families, of PGG Wrightson Ltd, its associated companies and advertising agencies are ineligible to submit photos to the LandMarks Photo Collection.

2020 CALENDAR COMPETITION

21. Photos submitted between 1 July 2018 and 21 June 2019 will be eligible for consideration as an entry in the [2020 PGW Calendar competition](#).

22. Entries for the Calendar Competition must meet the PGW LandMarks Photo Collection [Submission Criteria](#) to progress further to the Calendar Competition.
23. Entries must be of suitable resolution and image quality for reproducing a high-quality print at approximately A4 size.
24. Entries must be landscape-oriented for the Calendar or have the ability to be applied to a landscape format without being detrimental to the entry's qualities.

CALENDAR COMPETITION JUDGING AND PRIZES

25. A judging panel will select 12 winners and the People's Choice Award winner for the PGW 2020 Calendar.
26. The twelve winners and the People's Choice Award winner will each receive a \$250 (incl GST) PGW voucher. The vouchers will be issued according to the usual terms that apply to the use/expiry of PGW vouchers.
27. The Supreme winner will be selected from the top twelve winners and will also receive a \$1,500 (incl GST) Visa Prezzy Card.
28. The winners will be notified by telephone or email. Inability to contact the winner within fourteen days of selection will result in the prize being forfeited. An alternative finalist entry will be selected to receive the prize and be included in the 2020 PGW calendar.
29. The judging panel's decision is final and no correspondence will be entered into.
30. The prizes are not exchangeable or transferable except as expressly stated.
31. The prizes are subject to availability and may differ to the prizes specified. If the exact prize is not available, a prize of a similar value and specification will be awarded instead.
32. The prize will only be delivered in New Zealand. The winner should allow 28 days from notification for delivery. In the event that the winner is a New Zealand citizen currently located overseas, the winner must supply a New Zealand address for the prize to be delivered to.
33. Prior to receiving the prizes, the winners may be required to show proof of identity, for example, their passport or driver's licence.
34. The winners consent to their name, city/town of residence and photo being used for public relations purposes relating to this promotion in any media for an unlimited period without remuneration.
