PGW can withdraw approval for billing if you exceed your PGW credit limit and/or don't pay PGW by the 20th of the month following, and/or if you don't adhere to PGW's Customer Terms of Trade (see www.pggwrightson.co.nz/terms).</p> <p>3. If PGW withdraws their approval, or if you close your account with PGW, you will move to Farmside standard pricing and may be subject to a credit check.</p> <p>4. PGW will bill your PGW account the monthly amounts owing on your Farmside account, after receiving this information from Farmside.</p> <p>5. PGW will pay Farmside for any amounts due on your Farmside account, even if an amount is disputed by you. You must pay PGW the full amount of all charges from Farmside even if you</p>	<p>dispute them. You must take up any disputes directly with Farmside as outlined in their Standard Terms and Conditions</p> <p>6. Farmside reserves the right to change the terms of the plan, by giving you 30 days written notice, if their contract with PGW ends.</p> <p>7. This agreement is also subject to Farmside's Standard Terms and Conditions, which is available at www.farmside.co.nz, except that your obligation to pay the charges under those terms and conditions is to PGW not to Farmside. When the Farmside charges are debited to your PGW Trade Account then PGW's Terms of Trade also apply to the extent PGG Wrightson deems relevant.
