3. Terms and Conditions

- Provision of the PGW Mercury Energy Plan benefits is only available to current PGW Trade Account holders, and is subject to approval by PGW.
- PGW can withdraw approval for billing if you exceed your PGW credit limit and/or don't pay PGW by the 20th of the month following, and/or if you don't adhere to PGW's Customer Terms of Trade (see www.pggwrightson.co.nz/terms).
- If PGW withdraws their approval, or if you close your account with PGW, you will move to Mercury's standard Prompt Payment Discount plan.
- PGW will bill your PGW account the monthly amounts owing on your Mercury account for your electricity consumption and the associated charges, after receiving this information from Mercury.
- PGW will pay Mercury for any amounts due on your Mercury account, even if an amount is disputed by you. You must pay PGW the full amount of all charges from Mercury even if you dispute them. You must take up any disputes directly with Mercury as outlined in their Standard Terms and Conditions for Business Holders.
- This Plan may not be combined with any of Mercury's other partnership Plans.
- This Plan is available for your non-Half Hour Register metered ICPs and/or your Half Hour Register ("HHR") metered ICPs but the discount (of 12%, as at the time of printing) does not apply to the HHR metered ICPs.
- Mercury reserves the right to change the terms of the Plan, by giving you 30 days written notice, if their contract with PGW ends.
- This agreement is also subject to Mercury Energy's Standard Terms and Conditions for Business Customers, which is available at www.mercury.co.nz/terms, except that your obligation to pay the charges under those terms and conditions is to PGW not to Mercury. When the Mercury energy charges are debited to your PGW Trade Account then PGW's Terms of Trade also apply to the extent PGG Wrightson deems relevant. - You agree to indemnify PGW in full against any claims whatsoever from Mercury Energy or from third parties, arising from this billing agreement and/or breach of Mercury Energy's Terms and Conditions.
