### RURAL SUPPLIES



Stores are open with 1m distancing.

Face coverings (excluding exemptions) and QR-code scanning/record-keeping are mandatory.

All products available for purchase.

Payment instore by PGW account, credit card, EFTPOS, or cash.

Technical Field Reps able to travel between regions for on-farm visits.

### FRUITED SUPPLIES



Stores are open with 1m distancing.

Face coverings (excluding exemptions) and QR-code scanning/record-keeping are mandatory.

All products available for purchase.

Payment instore by PGW account, credit card, EFTPOS, or cash.

Online purchases available at [store.pggwrightson.co.nz](http://store.pggwrightson.co.nz).

Technical Horticultural Reps able to travel between regions for orchard visits.

### WATER



Water branches are open with 1m distancing.

Face coverings (excluding exemptions) and QR-code scanning/record-keeping are mandatory.

All products available for purchase.

Payment instore by PGW account, credit card, EFTPOS, or cash.

Water Reps able to travel between regions for on-farm visits.

### LIVESTOCK



Saleyards and on-farm sales limited to 100 people and 1m distancing.

All attendees will be legally required to provide their Vaccine Pass. Attendees may be required to provide photo ID alongside the pass.

Face coverings and QR-code scanning/record-keeping are encouraged.

Livestock paddock sales conducted by agents.

Velvet processing operational for collection and delivery to Prebbleton.

### WOOL



Wool stores are open with 1m distancing.

Wool auctions limited to 100 people and 1m distancing.

Wool offices are open with 1m distancing.

All visitors will be legally required to provide their Vaccine Pass. Visitors may be required to provide photo ID alongside the pass.

Face coverings (excluding exemptions) and QR-code scanning/record-keeping are encouraged.

Wool Reps able to travel between regions for on-farm visits.

### REAL ESTATE



Real Estate offices open with 1m distancing.

Face coverings (excluding exemptions) and QR-code scanning/record-keeping are encouraged.

Agents able to appraise, list and market properties.

Open homes and buyer property viewings are permitted:

Properties with Vaccine Pass: Up to 100 people, 1m distancing in a defined space at any one time.

Properties without Vaccine Pass: Up to 25 people, 1m distancing in a defined space at any one time.
