### **PGG Wrightson Ltd (PGW) LandMarks Photo Collection and 2023 Calendar Competition Terms**

#### **LANDMARKS PHOTO COLLECTION SUBMISSIONS**

1. All photos must be submitted online via the PGW website at [www.pggwrightson.co.nz](http://www.pggwrightson.co.nz). There is no limit of photos per person.
2. All submitted photos are likely to be displayed in a photo gallery on the PGW website. PGW reserves the right to remove submissions from the gallery at its own discretion.
3. It is the photographer's responsibility to obtain consent from all photographed persons and owners of recognisable photographed property prior to being photographed including consent to these terms and photos submitted to the LandMarks Photo Collection.
4. The photographer gives permission for all photos submitted to be used by PGW and grants an irrevocable royalty-free licence to PGW to store all photos submitted, use all photos free of charge in any of its online and print publications for an indefinite period, noting that once printed, images are permanent. The photographer will be acknowledged where practicable.
5. Submission of a photo is deemed acceptance of these terms.

#### **CALENDAR COMPETITION CRITERIA**

6. All photos submitted to the Landmarks Photo Collection between 18 August 2021 and 30 June 2022 will be eligible for the PGW 2023 Calendar Competition.
7. Up to 12 Calendar winners, including a Supreme winner will be selected for the PGW 2023 Calendar. The decision is final and no correspondence will be entered into.
8. Photos selected for the calendar must be of suitable resolution and image quality for reproducing a high-quality print at approximately A4 size.
9. PGW 2023 Calendar winners must, within fourteen days of being contacted, be able to provide written proof of consent from:
  - a. all photographed persons.
  - b. the parent/guardian for any photographed person under the age of 18.
  - c. the property owner for recognisable photographed property (excluding aerial views, extreme close ups, own property or public property).
10. Failure to provide documentation of consent upon request by PGW, for photographed persons or property will deem the photo ineligible for the PGW 2023 Calendar Competition. PGW reserves the right to establish whether proof of consent is required.

#### **CALENDAR COMPETITION PRIZES**

11. The Calendar winners will each receive a \$250 (incl GST) PGW voucher. The vouchers will be issued according to the usual terms that apply to the use/expiry of PGW vouchers.
12. The Supreme winner will be selected from the PGW 2023 Calendar winners and will also receive a \$1,500 (incl GST) Visa Prezy Card,

plus placement on the PGW 2023 Calendar cover.

13. PGW 2023 Calendar winners will be notified by telephone or email. Inability to contact the winner within fourteen days of selection will result in the prize being forfeited and an alternative entry will be selected to receive the prize and be included in the PGW 2023 Calendar.
14. The prizes are not exchangeable or transferable except as expressly stated. The prizes are subject to availability and may differ to the prizes specified. If the exact prize is not available, a prize to a similar value and specification will be awarded instead.
15. The prize will only be delivered in New Zealand. The winner should allow 28 days from notification for delivery. In the event that the winner is a New Zealand citizen currently located overseas, the winner must supply a New Zealand address for the prize to be delivered to.
16. Prior to receiving the prizes, the winners may be required to show proof of identity, for example, their passport or driver's licence.

#### **GENERAL**

17. The LandMarks Photo Collection and the PGW 2023 Calendar Competition are open to New Zealand residents and citizens only who are over 18 years of age.
18. Employees and contractors, and their immediate families, of PGG Wrightson Ltd, its associated companies and advertising agencies are ineligible to submit photos to the LandMarks Photo Collection or the PGW 2023 Calendar Competition.
19. PGW collects and holds participants' personal information solely for the purpose of receiving and using photos and conducting the Calendar Competition and will only use or disclose personal information in connection with this.
20. Submitters to the LandMarks Photo Collection and the PGW 2023 Calendar Competition winners consent to their name and city/town of residence being used for public relations purposes relating to this promotion in any media for an unlimited period without remuneration.
21. PGW is not responsible for photos that go astray. If participants fail to adequately fill out the submission form and/or submit a photo, it will not be accepted into the LandMarks Photo Collection.
22. Except for any liability that cannot be excluded by law, PGW and its suppliers exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the submission of photos, the Calendar Competition and any prizes.
